ON GOING COMMITTEE REPORTS

Ferry Advisory - Gary

Another interesting week. Big boat had power failure and it will be out of service for 4 months. So, they pulled the Sealth from our route and they added an old one (Tillicum – smaller) back in.

The next executive meeting was moved to July 28th.

Gary is not clear on when the traffic officers will be funded - - when the budget will go into effect. The budget that was approved is for 2016.

Vashon has asked for years that we eliminate parking all together in front of the park (so ferry line could easily form there)

There was discussion about how we could try to get help with the traffic control. Gary reminded everyone that he had worked hard to get the traffic patrol added to the budget and that he didn't want to jeopardize that.

Gordon mentioned idea to call or white a letter to the WS Precinct as it's also a public safety issue. ACTION: He said he would make the call.

Bruce mentioned that the construction on Vashon may be causing part of the issue and that they may be able to help pay for the officers.

Car2Go - Gary

Gary mailed a letter to Tom R's office but hasn't yet received a reply.

He hasn't heard back from his Car-To-Go contact. The company is concerned about them violating their ordinance by paying for the parking behind the schoolhouse.

SW District Council - Vicki

The current administration has been working to put energy back into this group.

For the special project \$\$ - they received 7 votes for California and Juneau and 4 votes for another project.

Mardi mentioned that there is a map on the mayors website that shows where multi-family areas are going to grow – both taller and wider.

ACTION: We need to begin giving Vicki our topics for her to take to these meetings, during her report.

Fauntleroy School House - Vicki

Their enrollment at the Children's Center is at capacity – huge enrollment.
