Frank Immel called the meeting to order at 6:00 pm.

## **Approval of June 10 Minutes**

Alan Grainger moved to approve the June 10, 2025 minutes. Bill Wellington seconded the motion. The minutes were approved.

## **Seattle Police Update**

Officer Beretta provided a year to date crime update for the Southwest precinct and Fauntleroy neighborhood. Fauntleroy has had an increase of one robbery to 25 ytd 2025 compared to 24 in 2024. Burglaries in Fauntleroy have decreased to five ytd 2025 compared to 10 in 2024. Thefts have decreased to 28 ytd 2025 compared to 49 in 2024. Vehicle theft has decreased to seven ytd 2025 compared to 21 in 2024. Confirmed shots fired increased to two ytd 2025 compared to one in 2024.

He advised the Board to report the Fauntleroy Park encampment on the Find it Fix it (FIFI) app. The more complaints recorded the better it is for the City Departments to track violations.

#### One Seattle Plan update

Catherine Bailey described the revised map that has removed the Schoolhouse and the block north of Brace Point on Fauntleroy SW from the increased density plan from the City. Susan Lantz-Dey moved that FCA support the map as drawn. Alan seconded the motion. The motion carried.

The City will be setting the revised boundaries on July 11, 2025.

#### Membership conversation

Increased membership in FCA continues to be an ongoing topic. Amber Heinemann will work with Bill to create a new QR code that can be specific to membership on FCA information. Amber will send the QR code to Judy Pickens to add to the newsletter. It was suggested that a "suggested donation" be advertised at any FCA events to offset expenses and continue the free admission to events. It was suggested that FCA could volunteer to staff a booth at the WS Farmers' Market. After much discussion, it was decided to create a Membership/Communication Committee to come up with specific ideas to improve these two areas and report back to the Board. Bill will chair the committee consisting of Board members and Dan Valente.

## **West Seattle Chamber Glass Float Hunt**

Bill moved that FCA sponsor two floats for hunt costing \$175. Bruce seconded. The motion passed. Amber will get the floats and hide them in the Fauntleroy area. Amber hid the FCA floats in 2024.

## **Financial Report**

Alan gave a financial report. YTD the budget for contributions is \$12,000 and actual is \$4000.

## Fall Festival Fundraiser update

Reed Haggerty reported that the fundraiser at Super Deli Mart raised \$600 for the Festival. Reed said it was a good turnout of new neighbors interested in the Fall Festival. Thank you to Super Deli Mart. Reed held a golf tournament over the July Fourth weekend as another fundraiser for the Festival. He estimates that this tournament will raise \$1,500. He will be holding this tournament annually.

Amber and The BirdHouse will be holding a summer barbeque fundraiser for the Festival on August 19 from 5 - 7. A portion of the barbeque sales will be donated to the Festival.

## Ferry update

Frank reported the next CAG meeting date has not been set.
